A. Music Program Disney Field Trip – Jocelyn Gross & Linsey Clauser

Ms. Gross and Ms. Clauser presented the music program field trip to Disney to the board. This trip is usually taken every four years, but due to COVID was postponed. The approximate costs will be \$1600 per person. They will be able to earn money through fundraisers and be able to use the funds in their individual accounts. The only costs to the district would be the costs for the substitutes.

B. Strength & Conditioning Coach – Mr. Brent Johnson

Mr. Johnson presented the possibility to hire a strength and conditioning coach. The current fitness room coverage is available every day and reliable. The addition of a strength and conditioning coach would help develop our athletes and make them stronger. This position would be handled like all other coaching positions. The cost would be a savings at the start.

C. 2021/2022 Health & Safety Plan

It was reported to the board that in order to receive ESSER III funds (2.6 Million) you need to build a Health and Safety Plan for returning in the Fall of 2021. Within the plan the

district has explained the strategies, policies, and procedures to meet the following ARP ESSER requirements:

- Handwashing and respiratory etiquette
