INSURANCE AGREEMENT

Tulpehocken Area School District provides students in grades 5-12 with a Dell laptop computer, and provides students in grades K-4 with an iPad with accessories in accordance with our technology mission to use technology to enhance our curriculum, to build communication, creativity, collaboration, and critical thinking skills that enable students to be globally aware, competitive, and adaptable in their personal and professional life.

Participation in the program is subject to the following terms and conditions:

- 4 The student must be actively enrolled at Tulpehocken Area School District
- 4 The device and related peripherals are on loan and remain the property of TASD
- Both student and parent/guardian agree to adhere to the Acceptable Use Policy
- Failure to comply with the Acceptable Use Policy may result in loss of device privilege.
- The student will be the exclusive user of this device and should not grant access to any other individual including family members.
- During the school day, administrators and teachers may monitor student use at any time including screen activity and Internet activity.
- Student device activity at home is managed by our school content filter and all Internet activity is logged for reference by school administration.
- Device, charger, and bag will be returned in good condition to school at the end of each school year.
- Proper care of the device and related peripherals are the responsibility of the student guardian while in his/her possession.
- Devices with any software issues or damage should be reported to the technology department immediately. At no time should devices be repaired or serviced by anyone outside the Tulpehocken Area School District.

TULPEHOCKEN DEVICE INSURANCE PLAN

Accidental damage coverage is available to any student in the Tulpehocken Area School District. This coverage fee can be paid via cash, check, or money order made payable to the **Tulpehocken Area School District**. All checks should have your child's name written on them and should be handed to the building secretary, or mailed to the **Technology Department**, **Tulpehocken District Office**, **27 Rehrersburg Rd**, **Bethel**, **PA 19507**. Families who choose not to purchase the insurance will be responsible for the full costs of repair or replacement for any damage incurred. The device repair costs can be found below. Please contact the building office for details.

Who: Any student in TASD can opt for the insurance coverage.

Cost: Insurance cost for the device is \$10 per school year.

If the damage is determined to be purposeful or negligent, an invoice will be sent to the parents. A police report must be filed to process a theft claim.
